*this choice requires the payment of an upfront fee calculated at 20 cents per protected gallon. Your day of delivery price will not exceed \$2.199 and if the KOSCO retail price is less than your capped price, you will be billed the lower of the two.

PROPANE _____ # of protected Gallons FIXED PRICE \$1.89 per gallon
